SCRATCH PROCEDURES

- THE SCRATCH/POSITIVE CHECK-IN FOR THURSDAY'S TIMED FINAL EVENT SHALL BE 60 MIN PRIOR TO THE START OF THURSDAY'S SESSION. (DTUCKER@PACSWIM.ORG) (707-980-2663) OR ON DECK WITH THE ADMINISTRATIVE REFEREE.
- THE SCRATCH DEADLINE FOR FRIDAY-SUNDAY'S PRELIMINARY HEATS SHALL BE 30 MIN AFTER THE START OF THE PREVIOUS DAY'S FINAL SESSIONS.
- THE SCRATCH/POSITIVE CHECK-IN DEADLINE FOR SUNDAY'S TIMED FINAL EVENT (800M FREE) SHALL BE AT 5:00 PM ON SATURDAY.



SCRATCH PROCEDURES (CONT)

IN ALL PRELIM HEATS OR TIMED FINAL EVENTS FOR WHICH AN ATHLETE HAS BEEN POSITIVELY CHECKED-IN, ANY ATHLETE WHO FAILS TO COMPETE WHO HAS NOT BEEN SCRATCHED WILL BE BARRED FROM FURTHER INDIVIDUAL EVENTS OF THAT DAY. ADDITIONALLY, THE ATHLETE SHALL NOT BE SEEDED IN ANY INDIVIDUAL EVENTS ON SUCCEEDING DAYS UNLESS THAT ATHLETE DECLARES AN INTENT TO SWIM TO THE ADMIN REFEREE PRIOR TO THE CLOSE OF THE SCRATCH DEADLINE FOR THAT DAY'S EVENTS.



SCRATCHING FROM FINALS

SCRATCHES FOR FINALS MUST BE SUBMITTED TO THE ADMIN REFEREE ON-DECK AT THE SCRATCH DESK. NO EMAILS OR SMS/TEXT FOR SCRATCHING FROM FINALS. AN ATHLETE QUALIFYING FOR FINALS (C-FINAL, B-FINAL, OR A-FINAL) MAY, WITHIN THIRTY (30) MIN AFTER ANNOUNCEMENT OF THE QUALIFIERS FOR THAT RACE, DECLARE THEIR INTENTION NOT TO COMPETE OR NOTIFY THE ADMIN REFEREE THAT THEY MAY NOT INTEND TO COMPETE AND FURTHER DECLARE THEIR FINAL INTENTIONS WITHIN THIRTY (30) MIN FOLLOWING THEIR LAST INDIVIDUAL PRELIMINARY EVENT.

ANY ATHLETE QUALIFYING FOR FINALS WHO FAILS TO COMPETE IN SAID FINAL SHALL BE BARRED FROM FURTHER COMPETITION FOR THE REMAINDER OF THE MEET, UNLESS EXCUSED BY THE MEET REFEREE.



DECLARED FALSE START (DFS)

PRELIMINARY EVENTS ONLY:

ONCE THE SCRATCH DESK/BOX CLOSES, ATHLETES WISHING "NOT TO COMPETE" IN A PRELIMINARY EVENT MAY DECLARE A FALSE START (DFS) BY REPORTING TO THE REFEREE PRIOR TO THE START OF THEIR HEAT WITHOUT PENALTY.



1500M FREE THURSDAY

1500M FREE WILL SWIM AS A TIMED FINAL ON THURSDAY. POSITIVE CHECK-IN IS SIXTY (60) MIN PRIOR TO THE START OF THURSDAY'S SESSION. SEEDED FAST TO SLOW. WILL NOT ALTERNATE SINCE 1- HEAT OF LADIES AND 3- HEATS OF MEN (PRE SCRATCH).



DISTANCE EVENT 800M FREE SUNDAY

WILL SWIM AS A TIMED FINAL ON SUNDAY. THE CHECK-IN DEADLINE IS SATURDAY AT 5:00 PM. THE FASTEST HEAT OF WOMEN AND OF MEN WILL SWIM AT THE BEGINNING OF FINALS ON SUNDAY. ALL REMAINING HEATS WILL BE SWUM FAST TO SLOW (NOT ALTERNATING) AT THE END OF SUNDAY'S PRELIMS. ATHLETES WISHING TO SWIM THE 800M FREE AT THE END OF PRELIMS RATHER THAN AT THE BEGINNING OF FINALS SHALL DECLARE THEIR INTENTION BY THE POSITIVE CHECK-IN DEADLINE.



FINALS

- THE TOP 24 ATHLETES FROM PRELIMS WILL ADVANCE TO THE FINALS
- FINALS WILL BE CONTESTED SLOW TO FAST (C-FINAL, B-FINAL, A-FINAL)
- ALTERNATES MAY BE PLACED IN BOTH C AND B FINALS WITHOUT RESEEDING
- (C AND B) FINALIST INTRODUCED AS THEY ARE SWIMMING
- (A) FINALIST INTRODUCED BEHIND THE BLOCKS PRIOR TO SWIMMING
- TOP 3 FINISHERS WILL RECEIVE A SPECIAL AWARD (AWARDS DESK)



MEET OPERATIONS

- PRELIMS SEEDED FAST TO SLOW WITH THE FIRST 3 HEATS CIRCLE SEEDED
- 400M FREE AND 400 IM FIRST 2 HEATS
- FLYOVER STARTS
- 50M EVENTS (TIMERS AT TURN END)



TAPING

- EXCESSIVE BANDAGES OR INJURIES (SEE MEET REFEREE)
- THERAPEUTIC ELASTIC (KINESIO) TAPE PROHIBITED





SWIM-OFFS

- REQUIRED FOR TIES IN PRELIMS FOR POSITIONS OF: 8,9 16,17, 24,25,26
- CHECK IN WITH THE "ON DECK" ADMIN REFEREE BEFORE YOUR ATHLETES LEAVE THE VENUE AFTER PRELIMS FOR ANY POSSIBLE SWIM-OFFS. ALL SWIM-OFFS WILL OCCUR PRIOR TO THE PRELIM SESSION'S BREAK.
- FAILING TO DO SO MAY RESULT IN A CONCEDING.

- TIME TRIAL REQUESTS MUST BE MADE BY 10 AM FRIDAY-SUNDAY AT THE ADMINISTRATIVE OFFICE.
- TIME TRIALS IS \$20 DOLLARS PER EVENT.
- 2 TIME TRIALS PER ATHLETE.
- A TIME TRIAL EVENT WILL COUNT TOWARDS THE 3 MAXIMUM PRELIMINARY EVENTS PER DAY.
